AMENDMENT TO WATER RIGHTS DEED

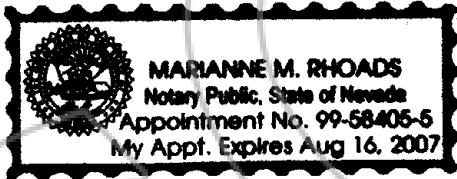
