Being a portion of the Northwest 1/4 of Section 23, Township 12, Range 19, M.D.B.& M., further described as:



rents, issues or profits thereof. To have and to hold the said premises unto the Grantee, and to the heirs and assigns of such Grantee forever.

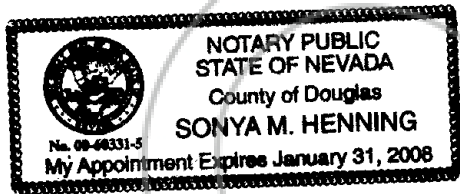
