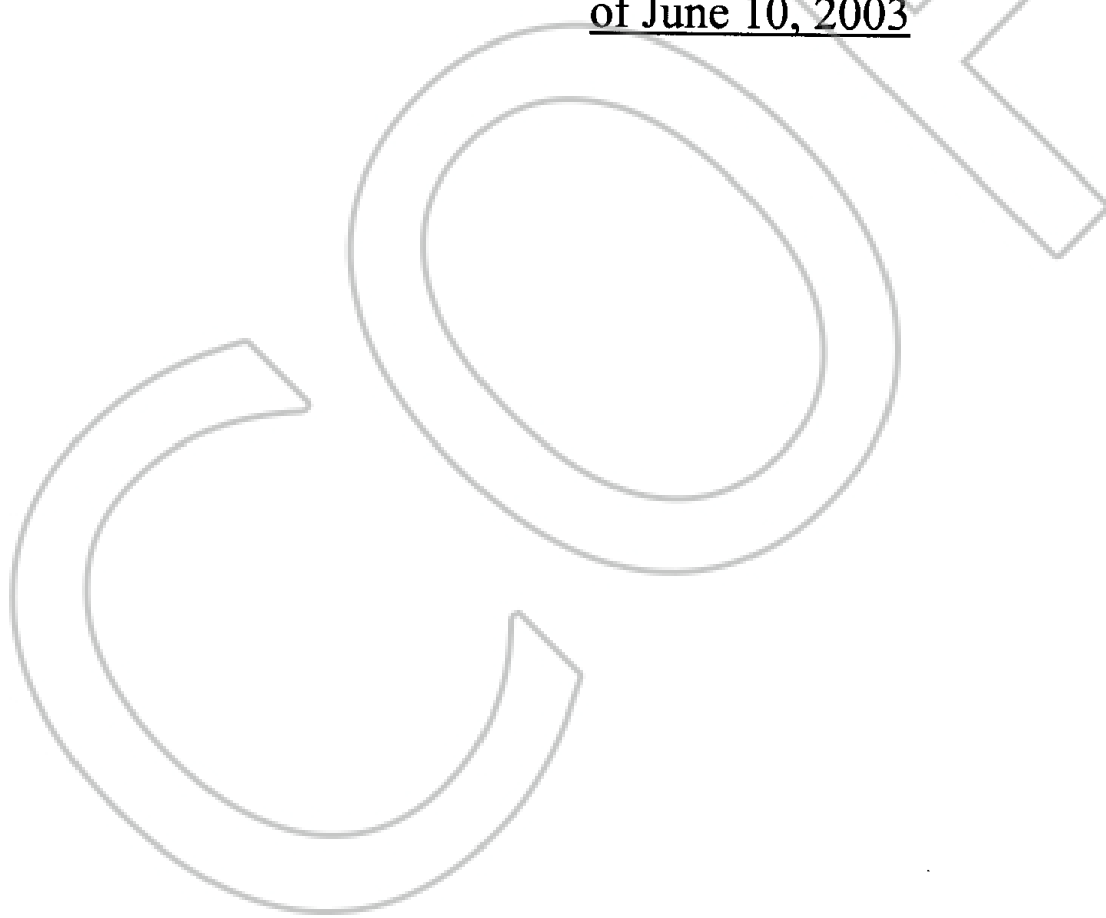

7. The amount due and owing under the Judgment of June 10, 2003, after the application of the partial payment of \$70,000 is pre and post judgment interest - \$79,627.86; principal balance - \$447,228.00, for a total of \$526,855.86 due as of this date.
