WITNESSETH:

That Grantor, in consideration for the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, paid to Grantor by Grantee, the receipt whereof is hereby acknowledged, does by these presents, grant, bargain, and sell unto the Grantee and Grantee's heirs and assigns, all that certain property located and situated in Douglas County, State of Nevada, more particularly described below and incorporated herein by this reference;

A TIMESHARE ESTATE COMPRISED OF:

- (A) An undivided 1/102nd interest in and to Lot 28 as shown on Tahoe Village Unit No. 3-13th Amended Map recorded December 31, 1991, as Document No. 268097, re-recorded as Document No. 269053, Official Records of Douglas County, State of Nevada, excepting therefrom Units 039 through 080, (inclusive) and Units 141 through 204 (inclusive) as shown on that certain; Condominium Plan Recorded July 14, 1988, as Document No. 182057; and

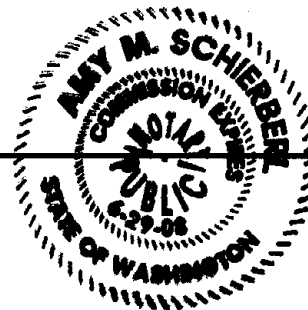
