2 Plaintiff's Motion for Attorneys' Fees and Costs was unopposed and is therefore granted, TP is  
3 entitled to a total judgment in the amount of \$14,339.36, plus attorneys' fees in the amount of  
4 \$9,802.50 and costs in the amount of \$538.02. The entire principal sum, exclusive of the attorneys'  
5 fees and costs listed above, shall continue to accrue interest pursuant to NRS 99.040 from the date  
6 the Complaint was served, May 9, 2001, until that entire principal sum is paid in full. Any payments  
7 shall first be applied to interest, fees and costs and only after said totals are completely satisfied, to  
8 the principal sum.

9 IT IS FURTHER ORDERED that judgment is entered against Defendants on their  
10 counterclaim and they are entitled to nothing thereon.
