NOTICE OF ADVANCE UNDER DEED OF TRUST

KNOW ALL MEN BY THESE PRESENTS: THAT WHEREAS, the undersigned, CURTIS D. KIMBREL, SUCCESSOR TRUSTEE OF THE SUZANNE MULKEY TRUST DATED MARCH 15, 1978, as Trustor by a certain Deed of Trust dated May 5, 2004 and recorded June 2, 2004 in the office of the County Recorder of the County of DOUGLAS, State of Nevada, Instrument No. 614978, Book 0604, at Page 1115-1119, granted and conveyed the real property therein described to STEWART TITLE OF DOUGLAS COUNTY as Trustee, to secure the payment of certain promissory note of even date therewith for \$200,000.00 in favor of LARRY J. 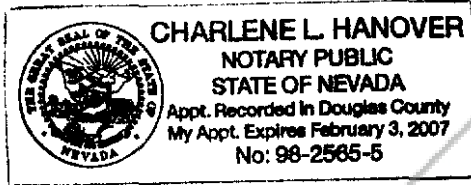
