THIS INDENTURE, made this 19th day of March, 2005 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and F. WOODSIDE WRIGHT and JUDITH M. WRIGHT, husband and wife as joint tenants with right of survivorship Grantee;

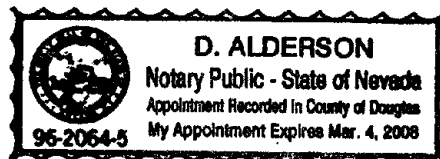
