IT IS ORDERED, ADJUDGED, AND DECREED that the said plaintiff, AHERN RENTALS, INC., a Nevada corporation, shall have judgment against and recover of the defendant, JOHN DENNIS NAU, also known as J.   - e) \$ 22,245.80 plus interest from June 18, 2003 (30 days after 5/19/03 invoice date)
