THIS INDENTURE, made this 2nd day of April, 2005 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and WILFRED R. CARLSON, JR. and WENDI L. CARLSON, husband and wife as joint tenants with right of survivorship Grantee;

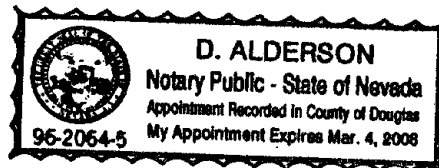
