**JUDGMENT BY DEFAULT AND ORDER  
GRANTING WRIT FOR IMMEDIATE  
POSSESSION**

The Court having considered the application for entry of judgment by default and order granting writ for immediate possession, the affidavit of counsel, and the papers and pleadings on file, including the verified Complaint.

Good cause appearing, the Court finds: (1) that Plaintiff is entitled to possession, use and disposition of the Collateral identified as a 1991 Toyota V6 Pick-Up 4x4 Extended Cab, VIN# JT4VN01D4L2008619; (2) that this is an appropriate action for issuance of a Writ For Immediate Possession; and (3) that no bond shall be required for the issuance of the Writ For Immediate Possession because Plaintiff is a secured party pursuant to Nevada Revised Statute Chapter 104. The Court being otherwise fully advised in the premises and good cause appearing,

JUDGMENT is hereby entered in favor of Plaintiff CitiFinancial, Inc. and against Defendant Adam D. Randall as follows:

1           1.       Plaintiff CitiFinancial, Inc. is entitled to immediate and sole possession of the  
2 Collateral described as a 1991 Toyota V6 Pick-Up 4x4 Extended Cab, VIN#  
3 JT4VN01D4L2008619 and Defendant is hereby ordered to immediately surrender exclusive  
4 possession of the Collateral to CitiFinancial, Inc. forthwith.

5           2.       A Writ For Immediate Possession shall be issued and the Sheriff of Douglas  
6 County, Nevada, shall take into custody the above-described property possessed by the Defendant  
7 wherever the property may be located in Douglas County, State of Nevada.

8           3.       Plaintiff CitiFinancial, Inc. may proceed to sell the Collateral in conformance with  
9 NRS Chapter 104 and applicable case law.

10          4. Plaintiff CitiFinancial, Inc. is awarded damages of \$6,020.10, plus interest at the rate  
11 of 29.55% from January 20, 2005 until paid in full.


12          5.       Plaintiff CitiFinancial, Inc. is awarded attorney's fees incurred in the amount of  
13 \$750.00

14          6.       Plaintiff CitiFinancial, Inc. is awarded costs of suit incurred in the amount of  
15 \$237.13.


