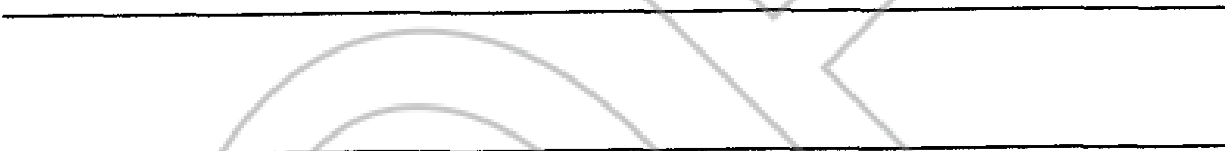

4. For costs of suit in the amount of 224; and



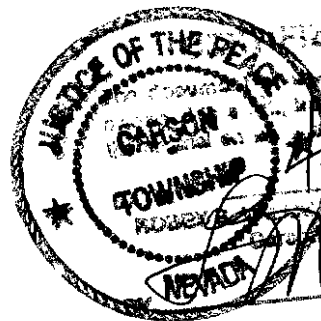
