28 BLADES CONSTRUCTION, the following amounts:



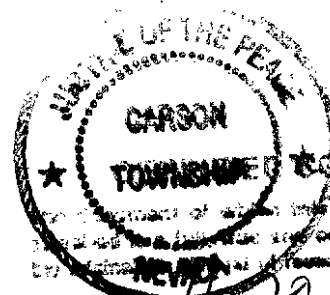
