## MODIFICATION OF NOTE SECURED BY DEED OF TRUST

WHEREAS, Trustor has heretofore executed and delivered for valuable consideration, a Promissory Note in the original sum of \$129,250.00, in favor of beneficiary named herein, and dated May 25, 1999 and

WHEREAS, said note is secured by a Deed of Trust in like amount and of even date therewith, which Deed of Trust recorded on June 1, 1999, in Book 0699, at Page 156, under Document No. 0469322.

NOW THEREFORE, in consideration of the mutual benefit of the parties hereto, said note hereinabove referenced shall be modified as to the following particulars:

Robert L. Hook and Donna M. Hook, husband and wife, promise to pay to THE GALEN STUART VINCENT TRUST DATED JULY 20, 1998 the principal sum of \$121,175.28 with interest at the rate of 7% from April 1, 2005.
