

- 3. That the Application for Entry of Judgment included a request to amend the amount of damages prayed for in the complaint to include additional sums due as a result of defendant Thulin's failure to pay common area and other expenses as required by the Stipulation.
- 4. That the CC&R's by its terms require that defendant Thulin pay a forty percent (40%) pro rata share of all common area and other expenses.
- 5. The Court has determined based on the Stipulation attached as **Exhibit A** to the Application for Entry of Judgment and the affidavits filed herein, the amount due from defendant Thulin is the amount of Twenty Nine Thousand Fifty Five Dollars and 57/100 (\$29,055.57).
- The Court has determined that based on the affidavit of Pierre A. Hascheff the amount of reasonable attorneys fees and costs incurred in this action is One Thousand Two Hundred Dollars (\$1,200.00).
