DAVID WALLEY'S RESORT GRANT, BARGAIN, SALE DEED

THIS INDENTURE, made this 11th day of May, 20 05 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and IRMA J. T. B. WELCH, an unmarried woman and DEBRA J. BARKER, a single woman together as joint tenants with right of survivorship Grantee;

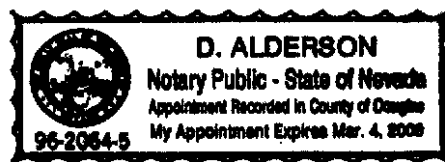
