**DEED OF FULL RECONVEYANCE**

NOW, THEREFORE, Western Title Company, as Trustee, does hereby grant and reconvey unto the party or parties legally entitled thereto, without warranty, all of the estate and interest vested to it under said Amended Deed of Trust, in and to that certain real property situate in the County of Douglas, State of Nevada, which is more particularly described on that certain exhibit marked "Exhibit A", affixed hereto and by this reference incorporated herein and made a part hereof.



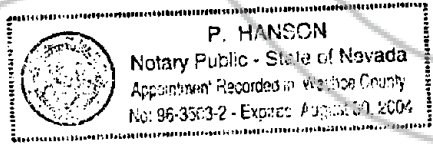

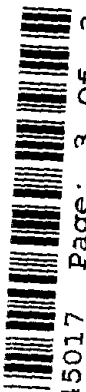
