THIS INDENTURE, made this 23rd day of May, 2005 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and DONAL STEVEN GAMET and CHARLENE E. GAMET, husband and wife as joint tenants with right of survivorship Grantee;
