4 (BELDING, HARRIS & PETRONI, LTD.), signed by Debtors MICHAEL PATRICK TAYLOR
5 and MARLENE F. LADAGE, filed herein on July 25, 2003, and the SUPPLEMENT TO
6 APPLICATION BY DEBTORS' ATTORNEY REQUESTING APPROVAL FOR AMENDED
7 SECOND AND FINAL COMPENSATION AND REIMBURSEMENT OF EXPENSES (BELDING,
8 HARRIS & PETRONI, LTD.) filed herein on July 25, 2003; and the Court having

14 for payment, for the total sum of **\$87,745.70**, comprised of the sum of \$74,721.25,
15 based on 233.05 hours spent in rendering professional legal services, billed at the rate
16 of \$250.00 per hour for a total of \$58,262.50, for Stephen R. Harris, Esq.; and 73.15
17 hours spent in rendering professional legal services, billed at the rate of \$225.00 per
18 hour for a total of \$16,458.75, for Chris D. Nichols, Esq.; in addition to reimbursement
19 for necessary costs and out-of-pocket expenses that have been expended by Debtors'
20 Attorney in the amount of \$10,470.95 (costs), and supplemental legal fees and costs
21 incurred from July 1, 2003, through the date of hearing on July 23, 2003, in the amount
22 of \$2,553.50; for a net unpaid amended second and final fee request of **\$87,745.70**;

24 **IT IS FURTHER ORDERED** Debtors' Attorney has agreed to voluntarily discount
25 the Court-approved legal fees/costs from the total sum of \$87,745.70 to \$60,000.00,
26 if the \$60,000.00 is paid to Debtors' Attorney on or before October 15, 2003, and
27 assuming the Debtors do pay Debtors' Attorney the sum of \$60,000.00, by the deadline
28 dated October 15, 2003, then the Debtors' Attorney shall accept said payment of

1 \$60,000.00 in full and final satisfaction of his Court-awarded legal fees and costs
2 incurred through July 23, 2003; and

3 **IT IS FURTHER ORDERED** that the above-delineated request for payment of
4 amended second and final legal fees and costs, as supplemented, is hereby ratified and
5 approved for payment and is deemed an allowed 11 U.S.C. §503(b) administrative
6 expense.
