COLLATERAL ASSIGNMENT OF DEEDS OF TRUST

and any replacement or substitute notes issued therefor;

- All amounts at any time owing by the undersigned to Lender on account of the 4. promissory note of the undersigned payable to the order of Lender, dates as of June 5, 1998, in the amount of Four Million Dollars (\$4,000,000.00) and delivered to Lender pursuant to the Construction Loan Agreement, and all amendments, modifications, increases and reductions thereof and any replacement or substitute notes issued thereof;
- All amounts at any time owing by the undersigned to Lender on account of the 5. promissory note of the undersigned payable to the order of Lender, dated as of June 5, 1998, in the amount of Eight Hundred Thousand Dollars (\$800,000.00) and delivered to Lender pursuant to the Construction Loan Agreement and all amendments. modifications, increases and reductions thereof and any replacement or substitute notes issued therefor;
- All amounts at any time owing by the undersigned to Lender under any provisions of 6. the Construction Loan Agreement or any documents collateral thereto;
- All other sums now or at any time owing by the undersigned to Lender pursuant to any 7. existing or future loans or credit facilities extended to the undersigned; and
- All costs of collecting said amounts, including reasonable attorneys' fees. 8.

The undersigned does hereby agree to warrant and forever defend the title to such Deeds of Trust and Notes unto Lender, its successors and assigns against any claims of any person whatsoever.

The undersigned represents and warrants to Lender, its successors and assigns that such Notes and Deeds of Trust are conveyed hereunder, free and clear of any lien, claim or encumbrances of any nature.


