

ORDER APPROVING FIRST AND FINAL ACCOUNT, REPORT OF ADMINISTRATOR, PETITION FOR ALLOWANCE OF ATTORNEY'S FEES AND COSTS, FOR FINAL DISTRIBUTION AND FOR FINAL DISCHARGE

NANCY REY JACKSON, Petitioner of the above-entitled estate, having filed her verified First and Final Account, Report of Adminitrator, Petition for Allowance of Attorney's Fees and Costs, For Final Distribution and For Final Discharge, and the same coming on regularly for hearing this 7th day of May, 2005, before the above-entitled Court. The Court having reviewed the First and Final Account, Report of Administrator, Petition For Settlement Thereof, for Allowance of Attorney's Fees and For Final Distribution and for Final Discharge, finds that due notice has been given in conformity with law and that the beneficiaries of decedent's estate, her two daughters, have received due notice of this hearing as required by law; that this Court being fully advised in the premises, further finds:

- All allegations contained in the First and Final Account, Report of Executor, Petition 1. For Allowance of Attorney's Fees and Costs, For Final Distribution And For Final Discharge are true.
- The Decedent, CAROLE P. MACKEN, died intestate on September 28, 2002, in 2. Douglas County, Nevada and was at the time of her death a resident of Douglas County.
 - 3. On June 21, 2004, this Court entered its Order Approving Petition for Administration

of Estate and for Issuance of Letters of Administration and appointing Nancy Rey Jackson Administrator of the estate as the request of the decedent's heirs.

- 4. Petitioner took the statutory oath of office as administrator and Letters of Administration were filed with this Court on June 21, 2004. The Letters have not been revoked.
- 5. Petitioner published the Notice to Creditors as required by NRS 147.010 and NRS155.020, with any known creditors also notified by mail, pursuant to law.
- 6. Petitioner has diligently made inquiry as to the existence of any creditor's claims and that only one claim has been filed. The one creditor's claim, filed by the treasurer of the home owners' association to which the decedent belonged. The claim should be paid.
 - 7. The statutory time period has run within which any further creditors can file claims.
- 8. There are no federal taxes due or payable on account of this Nevada estate proceeding. The decedent owed income taxes for the tax years 2002 and 2003. Those taxes have been paid.
- 9. The administrator has heretofore paid from the decedent's accounts various obligations of the estate including the real property taxes which had been and remained delinquent at the inception of the probate proceeding. She has also distributed some monies to the heirs by leave of court.

Exhibit B, being the detailed expenses incurred herein, is attached to the within First and Final Account and is incorporated herein by reference as if set forth herein verbatim.

- 10. The home of the decedent remains unsold at the heirs' request. They desire that title be transferred to them as tenants in common. The Court confirms and approves the heirs' decision.
- 11. The heirs engaged attorney Nancy Rey Jackson of the law firm of Nancy Rey Jackson, Ltd. to render the legal services necessary to the administration of the estate and Nancy Rey Jackson has performed all necessary and ordinary services on behalf of the estate, acting in the capacity of administrator as well as attorney for the estate. The administrator has also performed extraordinary services, some of which are set forth in the First and Final Account.
- 12. The net value of this estate is Four Hundred Thirty One Thousand Four Hundred Twenty Two Dollars and Fifty One Cents (\$431,422.51). There are also two savings accounts in the names of the decedent and her two grandsons, Anthony J. Halton and Brandon Macken, respectively.

- 13. An agreement exists between Attorney Jackson and the heirs that attorney's fees will be based at Two Hundred and Twenty-Five Dollars (\$225) per hour. She waived her fees as administrator of the estate. The fees and costs incurred during the period of administration were \$14,312.91.
- 14. Distribution, as mandated by the Nevada Revised Statutes, should be ordered, with the entire estate to be distributed to decedent's daughters, KIMBERLEY MACKEN and DIANNA MACKEN, with the assets recited in the order below.

THIS COURT finds good cause for the approval of said First and Final Account, Report of Administrator, Allowance of Attorney's Fees and Costs, For Distribution and For Final Discharge.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

- 1. The First and Final Account, Report of Administrator, Allowance of Attorney's Fees and Costs, For Distribution and For Final Discharge is hereby settled, approved and confirmed.
- 2. All acts and transactions of the Administrator relating to matters set forth in the Account, Report and Petition are confirmed and approved.
- 3. Petitioner, Nancy Rey Jackson, shall immediately pay the two remaining outstanding obligations of the estate.
- 4. Petitioner's payments of obligations outstanding at the decedent's death and incurred during the period of administration are hereby ratified, confirmed and approved. The administrator is authorized to retain the sum of \$750 to cover the remaining closing costs and expenses associated with the closing of the estate. Any amount left after the expenses are met shall be refunded to the heirs in equal shares.
- 5. The administration of this estate is brought to a close, subject to the administrator's filing with this Court appropriate receipts.
- 6. The administrator is directed to pay the law firm of Nancy Rey Jackson, Ltd., as and for attorney's fees, the sum of \$14,312.91, such sums including the costs incurred by said law firm.
- 7. Immediately after the administrator's payment of all attorneys' fees and costs, together with any other costs of administration of this estate, the entire net estate, being the rest, residue and remainder of said estate in the possession of the administrator consisting of the following, or its
