MODIFICATION OF DEED OF TRUST

The Note secured by a Deed of Trust is increased from \$2,750,000.00 to \$4,000,000.00. The word Note now means the Amended and Restated Revolving Construction Note dated June 13, 2005 in the amount of \$4,000,000.00 between Trustor and Bank, together with all renewals, extensions, modifications, refinancings and substitutions for the Note.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. 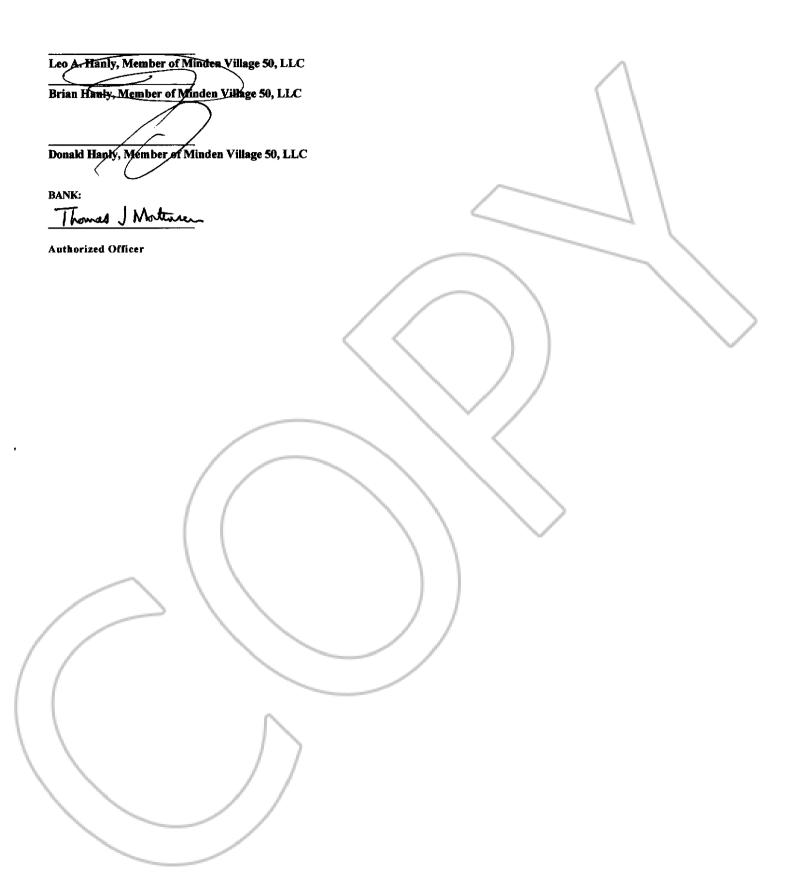
