NOTICE OF ADOPTION AND CURRENT EFFECTIVENESS OF WATER METER CHARGE WITHIN THE UNINCORPORATED TOWN OF MINDEN FOR ALL (1) NEW DWELLINGS, IN ACCORDANCE WITH NRS 278.385; (2) EXISTING DWELLINGS, UPON THEIR SALE AND CLOSING OF ESCROW TO NEW OWNERS

The Town of Minden ("Town") has adopted by resolution an amendment to its schedule of water rates. Effective immediately, a charge of \$550 is established for the purchase, installation, maintenance, and eventual replacement of water meters on each new residence within the Town and on each existing residence within the Town at the time it is sold by its current owner to another party. This charge must be paid to the Town at its office (1604 Esmeralda Street, Minden, Nevada) not later than (1) in the case of new homes, either from and after the date and time of issuance of the initial building permit, or in all events not later than the date of issuance by Douglas County of the first--either temporary or permanent--certificate of occupancy for the home (i.e. dwelling unit); and (2) in the case of existing homes without meters, not later than the closing of escrow of sale of the home to the new owner. This Notice will be recorded in the official records of Douglas County, Nevada. Solely as a courtesy, a copy of this Notice will be sent to each title company and real estate office in Minden and Gardnerville, Nevada.

Note: Labor costs incurred by the Town in reading water meters, recording meter readings, and analyzing the data derived from meter readings remain a component of the basic water charge for all water customers of the Town.
