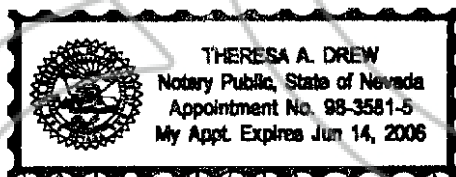
THAT the name of the record owner thereof is JOSE M. CARRANZA and CARMEN CARRANZA, husband and wife as joint tenants with right of survivorship.
