AMENDED ORDER APPROVING FIRST AND FINAL ACCOUNT, REPORT OF ADMINISTRATORS, PETITION FOR ALLOWANCE OF ATTORNEY'S FEES AND COSTS, FOR FINAL DISTRIBUTION AND FOR FINAL DISCHARGE

TERI KOZEN AND LESLEE RUSSELL, petitioners in the above-titled estate, having filed their verified First and Final Account, Report of Administrators, Petition for Allowance of Attorney's Fees and Costs, for Final Distribution and for Final Discharge, the same came on regularly for hearing this 6th day of June, 2005, before the above-entitled Court. The Court having reviewed the First and Final Account, Report of Administrators, Petition for Settlement Thereof, for Allowance of Attorney's Fees and for Final Distribution and for Final Discharge, finds that due notice has been given in conformity with law and that all persons entitled to notice have received due notice of this hearing as required by law; that this Court being fully advised in the premises, further finds:

- 1. All allegations contained in the First and Final Account, Report of Administrators, Petition for Allowance of Attorney's Fees and Costs, for Final Distribution and for Final Discharge are true.
- 2. The decedent, TIM STULL, died intestate on August 18, 2004, in Douglas County, Nevada and was at the time of his death a resident of Douglas County.
 - 3. On October 18, 2004, this Court entered its Order Approving Petition for

Administration of Estate and for Issuance of Letters of Administration, appointing Teri Kozen and Leslee Russell Administrators of the Estate.

- 4. Petitioners took the statutory oath of office as administrators and Letters of Administration were filed with this Court by Teri Kozen on October 18, 2004 and by Leslee Russell on November 17, 2004. The Letters have not been revoked.
- The Notice to Creditors was published as required by NRS 147.010 and NRS 155.020.
 No claims have been filed. The statutory time period has run within which creditors can file claims.
- 6. There are no federal estate taxes due or payable on account of this Nevada estate proceeding. The decedent's personal income tax return for the tax year 2004 were filed. There is a refund due in the amount of \$500.00. The Internal Revenue Service will forward the refund in Teri Kozen's name as soon as that agency has notice that Teri is entitled to receive those monies.
- 7. The administrator Teri has heretofore paid from the decedent's accounts as well as from her own monies various obligations of the estate, maintaining the real property and other assets left by the decedent. Teri has not filed a detailed account of the obligations paid nor requested any refund as any monies she advanced will be returned to her as the beneficiary of the decedent's estate.
- 8. The home of the decedent remains titled in his name. The administrators request that title in the home be transferred in the name of Teri Kozen as her sole and separate property. They also request that all other assets of the decedent be set aside or transferred to Teri Kozen
- 9. The Court has reviewed the disclaimers filed by the legal heirs of the decedent, in accordance with NRS 120.020. The legal heirs all disclaim any interest in their son's and brother's estate in favor of Teri Kozen, the decedent's long time companion. The Court approves the above request and confirms distribution to Teri Kozen.
- 10. The administrators engaged attorney Nancy Rey Jackson of the law firm of Nancy Rey Jackson, Ltd. to render the legal services necessary to the administration of the estate and Nancy Rey Jackson has performed all necessary and ordinary services on behalf of the estate, acting as attorney for the estate.
- 11. The net value of this estate is Three Hundred Twenty Nine Thousand Fifty Six Dollars (\$329,056).

- During the period of administration, and in the course of handling the affairs of the decedent, petitioners employed the services of Nancy Rey Jackson, Esq., who has rendered services to the estate and who has advanced costs of administration in the amount of \$ 523.10. (Due to a clerical error, the numbers were mistakenly noted in the first and final account as \$435.10, creating an error in the total fees and costs). Nancy Rey Jackson is entitled to reimbursement therefor. The fees together with the costs total \$4,223.10.
- 14. Distribution of the estate should be ordered, with the entire estate to be distributed to Teri Kozen, with the assets recited in the order below.

THIS COURT finds good cause for the approval of said First and Final Account, Report of Administrators, Allowance of Attorney's Fees and Costs, For Distribution and For Final Discharge.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

- 1. The First and Final Account, Report of Administrators, Allowance of Attorney's Fees and Costs, For Distribution and For Final Discharge is hereby settled, approved and confirmed.
- 2. All acts and transactions of the Administrators relating to matters set forth in the Account, Report and Petition are confirmed and approved.
- 3. Petitioner Teri Kozen's payments of obligations remaining outstanding at the decedent's death and incurred during the period of administration are hereby ratified, confirmed and approved. The administrator is authorized to retain the sum of \$250 to cover the remaining closing costs and expenses associated with the closing of the estate. Any amount left after the expenses are met shall be set aside to Teri Kozen.
- 5. The administration of this estate is brought to a close, subject to the administrators filing with this Court appropriate receipts.
- 6. The administrators are directed to pay the law firm of Nancy Rey Jackson, Ltd., as and for attorney's fees, the sum of \$4,223.10, such sums also including the costs incurred by said law firm.
- 7. Immediately after the administrators' payment of all attorneys' fees and costs, together with any other costs of administration of this estate, the entire net estate, being the rest, residue and remainder of said estate in the possession of the administrators consisting of the following, or its


