- I, Clarence Burr, do hereby declare as follows:
- 1. I am President of F. Heise Land & Live Stock Company, Inc., a Nevada corporation ("Heise"), and have access to Heise's books and records as they are kept in the ordinary course of Heise's business.
- 2. Heise was an original party to this proceeding and to the Judgment such that there are no successor-in-interest to Heise's right, title or interest in the Judgment.
- 3. On December 31, 1997, Heise commenced the above-entitled action against the above-named Defendants seeking payment for the sale and delivery of agricultural products, the value of which totaled Eleven Thousand Three Hundred Sixteen Dollars and Twenty-Four Cents (\$11,316.24), plus interest.
- 4. On August 27, 1999, the Court entered Judgment in favor of Plaintiff and against Defendant David L. Pruett in the amount of Seventeen Thousand Four Hundred Eleven Dollars and Thirty-Nine Cents (\$17,411.39) with interest thereon at the rate permitted by statute.

- 5. On November 16, 1999, the Court entered an Amended Judgment (which included costs and attorneys' fees) in favor of Plaintiff and against Defendant David L. Pruett in the amount of Thirty Thousand Two Hundred Fifty Dollars and Seventy-Five Cents (\$30,250.75) with interest thereon at the statutory rate.
- 6. The Amended Judgment was recorded with the Douglas County Recorder on January 3, 2000 as Document Number 0483764 in Book 0100 at Page 0327-28.
- 7. On November 24, 2005, Judgment was entered in this case against Garnishee Pruett Ranches, Inc., due to Pruett Ranches' failure to answer garnishment interrogatories, in the amount of Thirty Thousand Two Hundred Fifty Dollars and Seventy-Five Cents (\$30,250.75). This Judgment has not yet been recorded.
- 8. Plaintiff does not know the "number and page of the docket" in which the above-referenced judgments were entered as the Ninth Judicial District Court apparently does not maintain a Judgment Docket Book.
- 9. There are currently no outstanding writs of execution for enforcement of any of the above-referenced judgments.
