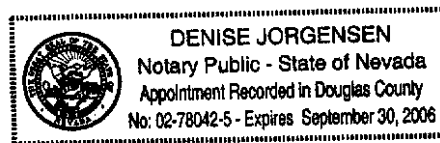

**A timeshare estate comprised of:**
