Said attorney-in-fact is authorized to execute a deed on our behalf.

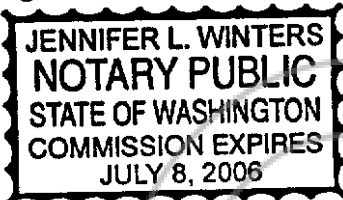

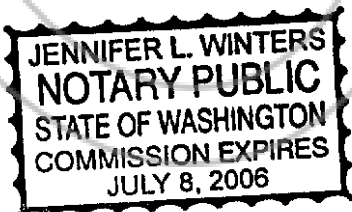
