GRANT OF EASEMENT

The Well, historically and presently, provides irrigation water to the HJ Ranch and neighboring properties. Any artesian water that is available that flows out of said well and enters grantors property can be utilized by grantor.

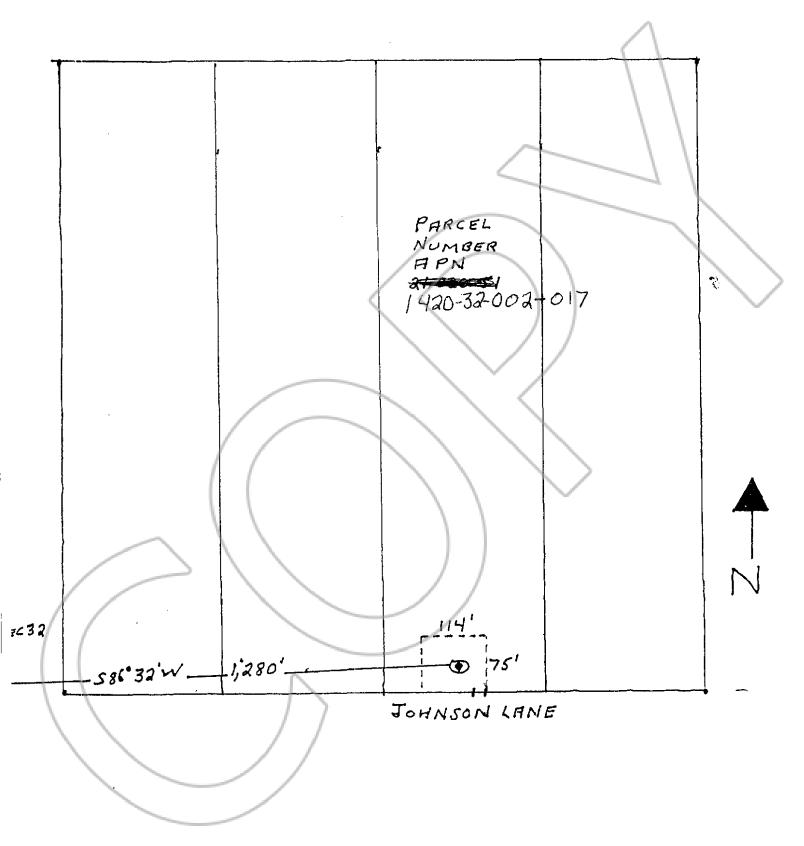
