WITNESSETH:





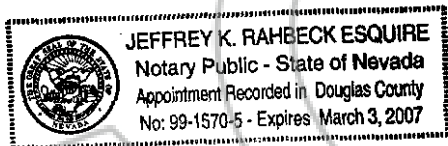
