DAVID WALLEY'S RESORT GRANT, BARGAIN, SALE DEED

THIS INDENTURE, made this 3rd day of October, 2005 between WALLEY'S PARTNERS LIMITED PARTNERSHIP, a Nevada limited partnership, Grantor, and SANDRA G. ZEHNDER, Trustee of the SANDRA G. ZEHNDER REVOCABLE LIVING TRUST dated June 8, 1988 Grantee;

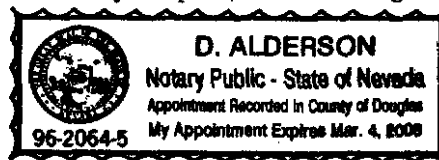
