15 The court entered a ruling from the bench after the trial of the above-entitled case and
16 makes the following orders in support of its findings for the plaintiff, Vesta Matzdorff. A copy
17 of the court's Findings of Fact, Conclusions of Law and Judgment will be filed with the court
18 clerk at a later date. In order to provide recordable notice to all interested parties immediately
19 of the court's findings and good cause appealing therefore,

20 IT IS HEREBY ORDERED that the RAVCO irrevocable trust executed by Vesta Fern
21 Matzdorff on or January 12, 2004 is judicially declared to be void and of no effect from the time
22 of its execution as though the trust had never existed. The RV1, RV2, and HWG trusts
23 executed by the plaintiff on January 12, 2004 are also declared void and of no effect as though
24 said trusts had never existed.

25 IT IS FURTHER ORDERED that all powers of attorney executed by Vesta Fern
26 Matzdorff granting powers to defendant Charles E. Stone are hereby declared void and of no
27 effect as though said powers of attorney had never existed.

1 IT IS FURTHER ORDERED that all contracts or other agreements for services,
2 compensation or pertaining to other matters executed by Vesta Fern Matzdorff and Charles
3 E. Stone are declared void and of no effect from the time of execution as though said
4 contracts or agreements had never existed.

5 IT IS FURTHER ORDERED that all real property, personal property, bank accounts,
6 notes, deeds of trusts, mortgages or other instruments held in the name of the RAVCO trust
7 shall be transferred and conveyed to Vesta Fern Matzdorff forthwith under the authority of this
8 order and without any requirement that any document be executed by any trustee of the
9 RAVCO trust in that said trust is void and has no legal standing.

10 IT IS FURTHER ORDERED that the interim trustee appointed by the court to act as the
11 trustee of the RAVCO trust, attorney James Hales, is fully relieved of his responsibilities as
12 interim trustee and shall transfer forthwith all assets, bank accounts or other property held in
13 the name of the RAVCO trust to Vesta Fern Matzdorff. The plaintiff shall be responsible for
14 promptly paying the bill for Mr. Hale's services while acting as trustee from the proceeds of the
15 bank account held in the name of the trust at Bank of America.
