22 Per its August 1, 2005, Order, this court found that
23 Third-Party Defendant and Counterclaimant Rock Island
24 Corporation was entitled to attorneys' fees pursuant to NRS
25 18.010 and NRCP 11. Further, the court invited Rock Island to
26 file its memorandum of costs and attorneys' fees.


27 Rock Island filed its Memorandum Re Attorneys' Fees and
28 Costs on August 5, 2005. Rock Island also served notice of

1 entry of the court's August 1, 2005, order the same day. No
2 party moved to retax the memorandum of attorneys' fees and
3 costs nor to have the August 1, 2005, order reconsidered.

4 As such, pursuant to NRS Chapter 18 and NRCP 11,
5 Defendants/Counterclaimants Michael Bogdanovich and Ruza
6 Bogdanovich are ORDERED to pay Rock Island Corporation the
7 additional sum of \$6,594.50 for attorneys' fees and costs
8 incurred by Rock Island in bringing its Motion to Enforce
9 Settlement Agreement and to Compel Payment in Full within sixty
10 (60) days of notice of entry of this order.

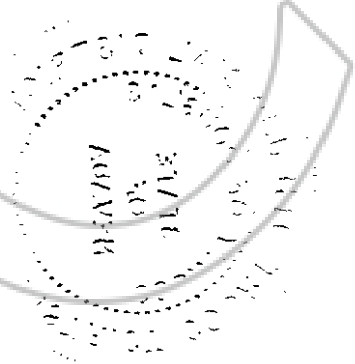
