Loan Modification Agreement

This Loan Modification Agreement ("Agreement"), made this 14th day of September, 2005 between Calvin Bosma, an unmarried man ("Borrower") and Walley's Partners Limited Partnership, a Nevada Limited Partnership ("Lender"), amends and supplements (1) that certain Short Form Deed of Trust and Assignment of Rents, dated August 7, 2004 and recorded August 20, 2004 in Book 0804, at Page 8309, as Document Number 621909 of the records of the Douglas County, Nevada Recorder's office ("Deed of Trust"), which encumbers the real and personal property described in the Deed of Trust and defined therein as the "Property", located at 2001 Foothill Road, Genoa, Nevada, described on Exhibit A attached thereto and incorporated therein and (2) that Promissory Note secured by Deed of Trust and Assignment of Rents executed by the Borrower and payable to the Lender dated the same date as the Deed of Trust ("Note").

In consideration of mutual promises and agreements exchanged for the purpose of curing the Borrower's default under said Note and Deed of Trust, the parties hereto agree to amend the Note and Deed of Trust as follows (to the Deed of Trust):

- As of October 19, 2005:
 - (a) The principal amount payable under the Note (the "Unpaid Principal") will be \$13,186.67
 - (b) The delinquent interest will be 1,295.33(the "Unpaid Interest"); and
- (c) The outstanding Accounting Service Charge under the Note will be \$40.00, ("Unpaid Service Charge").

Unpaid Principal only will be referred to herein as the "Unpaid Balance" as the borrower has paid a fee for this modification in lieu of the Unpaid Interest and Unpaid Service Charge being added to the loan balance.

- 2. The Borrower promises to pay the Unpaid Balance to the Lender as follows:
- (a) Beginning October 19, 2005, interest on the Unpaid Balance shall accrue at the rate of fourteen and ninety five one hundredths percent (14.95%) per annum; and
- (b) The Borrower shall make monthly payments to the Lender of principal and interest in the amount of \$217.24 beginning on November 19, 2005 and continuing thereafter on the same day of each succeeding month until May 19, 2015 ("Maturity Date") on which date all outstanding sums due under the Note or Deed of Trust shall be due and payable; and

- (c) All payments by the Borrower under the Note shall be made to P. O. Box 3187, Grand Rapids, MI 49501 or such other address as the Lender may notify the Borrower from time to time in writing.
- 3. In addition to the payments noted above the Borrower shall continue to pay a servicing fee of \$5.00 per month as set forth in the Note.
- 4. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Deed of Trust. Except as otherwise specifically provided in this Agreement, the Note and Deed of Trust will remain unchanged, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof.
- 5. The terms and provisions of this Agreement are confidential between the Borrower and the Lender or those acting as an agent for the Lender. Failure to maintain confidentiality of the terms and provisions of this Agreement by the Borrower will constitute breach of this Agreement and the Lender may pursue any rights and remedies as permitted by law.
