THIS RESCISSION OF NOTICE OF DEFAULT AND ELECTION TO SELL is made this 2 day of December, 2005, by the undersigned.

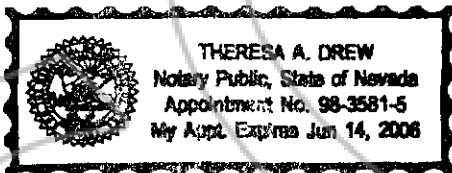
