## DEED UPON LIEN FORECLOSURE (The Ridge Sierra)

THIS DEED UPON LIEN FORECLOSURE is made on <u>December 12, 2005</u>, by STROSER ASSETS, INC., a Nevada corporation, as Agent for Q. M. CORPORATION, a Nevada corporation, successor in interest to the RIDGE SIERRA PROPERTY OWNERS ASSOCIATION, a Nevada corporation, by Assignment recorded December 8, 2005, as Document No. 0662639, Douglas County, Nevada, records, herein Grantor and Q.
