26 until this judgment has been satisfied, and;



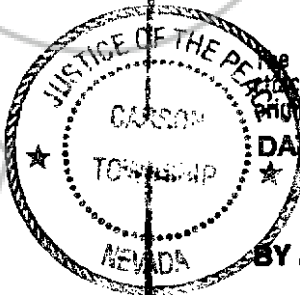
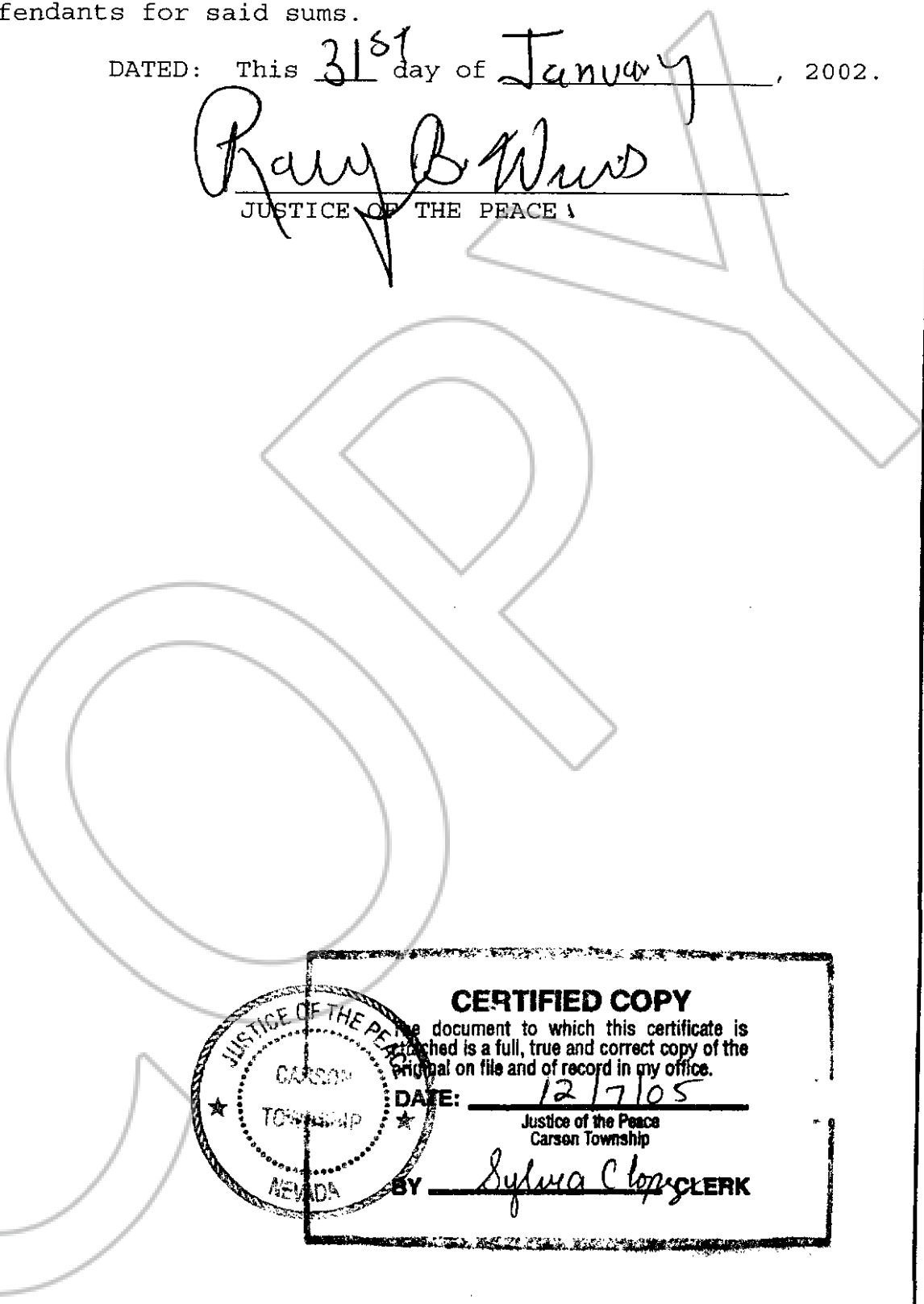
