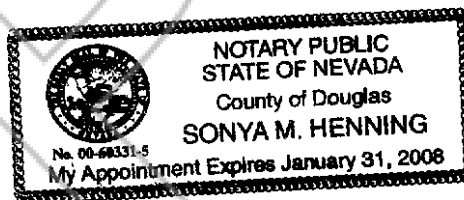



OFFICIAL OATH
