

6 KENT R. ROBISON, being first duly sworn on oath, does hereby swear under penalty of
7 perjury that the following assertions are true and correct.

8 1. This Affidavit is made pursuant to NRS Section 17.214 for the purpose of renewing
9 that certain Confession of Judgment entered in the above captioned matter on January 3, 2000.

10 2. I am the attorney of record for Plaintiff David R. Mounce and am duly authorized to
11 execute this Affidavit on his behalf.

12 3. A copy of the original Confession of Judgment entered on January 3, 2000 is attached
13 as Exhibit "A". The Judgment creditor named therein is David R. Mounce, Plaintiff, and the
14 Judgment debtor named therein is Ron Husey, Defendant.

15 4. The Judgment is for the principal sum of \$20,000.00, together with interest at the
16 legal rate thereof from January 3, 2000, until satisfied in full.

17 5. At the present time there is no outstanding Writ of Execution for enforcement of the
