
All that lot, piece or parcel of land situate in the County of DOUGLAS, State of Nevada, described as follows:

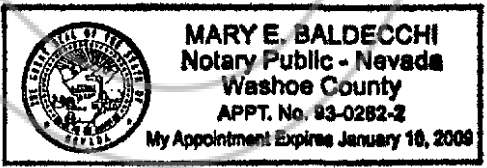
