10 26, 2006.

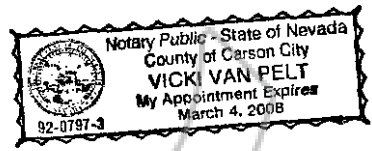

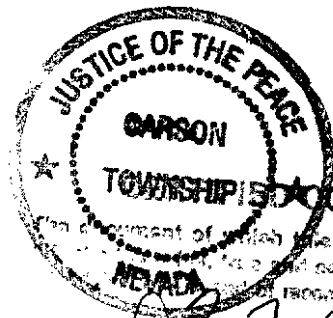
