That the said party of the first part, in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States of America, to it in hand paid on behalf of the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents convey unto the said party of the second part, and to its heirs and assigns forever, all those certain water rights situate in the Town of Minden, County of Douglas, State of Nevada, more particularly described as follows:

All rights, title, and interest in and to 1.12 acre-feet annually at a diversion rate of 0.0015 c.f.s., being a portion of Permit 60638, (Well #4) being the subject of Application 72266 on file at the State of Nevada, Division of Water Resources.

These water rights are being conveyed to provide dedicated water rights to Douglas County on behalf of David A. and Conny L. Merrill, to satisfy a condition under the approval of Parcel Map for David A. Merrill and Conny L. Merrill, LDA #04-007 by Douglas County. Consideration for the transfer of these water rights has been paid for by David A. and Conny L. Merrill to the Town in accordance with the Town's currently effective schedule of rates for groundwater rights.


