The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a N. 23 deg. E direction and 1480 feet in a S. 23 deg. 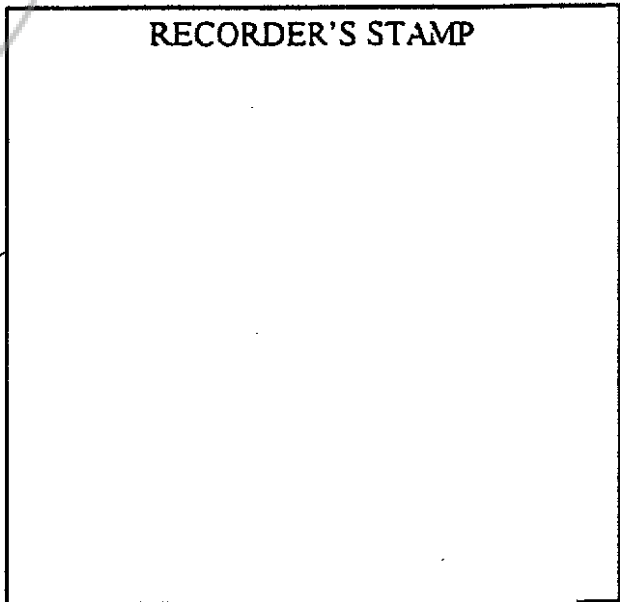
As erected on the ground, each corner monument is marked as described above by white wood post (e.g., metal tags, paint on posts).
