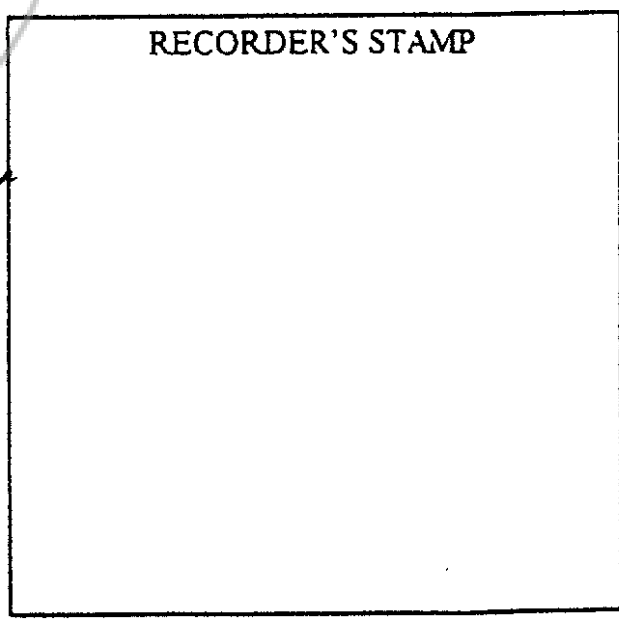
As erected on the ground, each corner monument is marked as described above by white wood post (e.g., metal tags, paint on posts).
