#### INTERLOCAL CONTRACT

This Agreement is made by and between Douglas County (County) a political subdivision of the State of Nevada and owner of the Ridgeview Sewer System, and the Indian Hills General Improvement District (IHGID), a local public improvement district in Douglas County.

#### RECITALS

IHGID and the County are public agencies under NRS 277.100. NRS 277.180(1) provides that any one or more public agencies may contract with any one or more other public agencies to perform any governmental service, activity or undertaking which any of the contracting agencies are authorized by law to perform; and

NRS 277.180(2) provides that the authorized purposes for contracts made pursuant to NRS 277.180 include the joint use of personnel, equipment and facilities, including sewer systems, for the promotion of the health, comfort, safety, life, welfare and property of the inhabitants of the counties and the general improvement district, which are parties to the contract; and

The County owns and operates the Ridgeview Sewer System and is interested in transferring the portion of the sewer system constructed under Phases 1 and 2 of the Ridgeview Sewer System Rehabilitation Project (Ridgeview Sewer System) to 1HGID. The board of trustees of IHGID is interested in accepting and operating the Ridgeview Sewer System.

#### **AGREEMENT**

In consideration of the mutual covenants contained in this agreement, the parties agree as follows:

#### ARTICLE I

#### TERM OF AGREEMENT

1.1 This agreement will be effective on the 18th day of January ,-2005 upon the approval of the IHGID board of trustees and the Douglas County board of county commissioners.

#### **ARTICLE II**

#### TITLE TO RIDGEVIEW SYSTEM

- 2.1 The Ridgeview Sewer System, as shown in Exhibits A and B, will become the sole property of IHGID, and IHGID will become solely responsible for operation and maintenance of the system in accordance with this agreement and all other requirements of law.
- 2.2 The County and IHGID agree that annexation of the Ridgeview Sewer System area is not contemplated by and is not a purpose intended by this agreement. The County and IHGID agree that any proposed future annexation must comply with all legal requirements, including citizen input concerning the process.

#### ARTICLE III

#### FEES FOR RIDGEVIEW SYSTEM

3.1 Ridgeview Sewer System users, identified in Exhibit C. who are on the Ridgeview Sewer System at the time this agreement becomes effective will not be charged connection or similar charges by IHGID. The County agrees to pay a \$5.00 billing set-up fee for each Ridgeview Sewer System user. Future sewer users who connect to the Ridgeview Sewer System after this agreement becomes effective will be required to pay connection and similar charges.

- 3.2 Any Ridgeview Sewer System users will, at all times, be charged in the same manner and at the same rate as IHGID system users.
- 3.3 Any vacant lots within the Ridgeview Sewer System service area that are built upon or connected in the future must, prior to connection, must comply with all requirements of IHGID.

#### ARTICLE IV

#### TERMINATION

4.1 This Agreement may be terminated by a written agreement to terminate signed by both parties.

#### ARTICLE V

#### **GENERAL PROVISIONS**

- 5.1 This agreement contains the entire agreement between parties about the subject matter and supersedes any and all agreements previously made between the parties. No change amendment, alteration or modification of this agreement will be effective unless documented in writing and executed by both parties.
- 5.2 Each respective party agrees to indemnify and hold harmless the other party, to the extent provided by law, including, but not limited to, NRS ch. 41, from and against any liability arising out of the performance of the agreement proximately caused by any act or omission of its own officers, agents, and employees.
- 5.3 This agreement will bind and inure to the benefit of the respective successors and any assigns to the parties.
  - 5.4 This agreement is made in and will be construed and governed by the laws of the

### State of Nevada.

5.5 The illegality or invalidity of any provision or portion of this agreement will not affect the validity of the remainder of the agreement.


