Deed Restriction

This Deed Restriction is made as of the ____ day of May, 2006, by and between Ray-Matt, LLC, a Nevada Limited Liability Company ("Ray-Matt"); and Douglas County, a political subdivision of the State of Nevada (the "County"), with reference to the following facts and is as follows:

- A. Ray-Matt is the owner of that certain real property situate in Douglas County, Nevada, more particularly described in Exhibit "A" hereto (the "Property").
- B. In connection with the development of the Property, the County has requested that Ray-Matt place a deed restriction on the Property for the benefit of the residents of the County.

NOW, THEREFORE, for valuable consideration, Ray-Matt hereby covenants and agrees with the County, for the benefit of the residents of the County, that the use of individual sewage disposal systems on the Property shall be limited to alternative treatment systems and installation of such alternative treatment systems must be approved and permitted by the Nevada Bureau of Health Protection Services before a building permit may be obtained. The provisions of this document shall be binding upon the successors and assigns of Ray-Matt and shall be deemed to run with the Property as covenants running with the land or as equitable servitudes, as the case may be, and shall constitute a burden on the Property for the benefit of the residents of the County.


