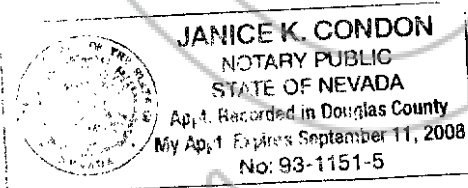
**BOUNDARY LINE ADJUSTMENT

- thence North 89°00'49" West, 254.99 feet to the POINT OF BEGINNING,

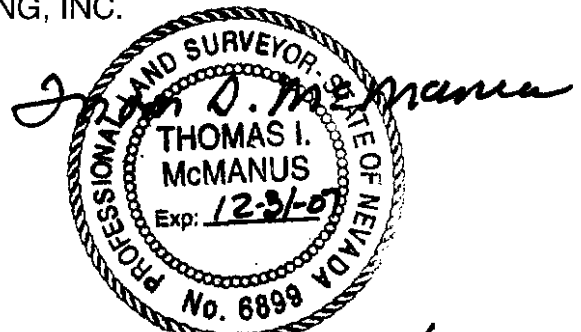
