SPECIAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, **Nathaniel M. Walsh** have made, constituted, and appointed, and by these presents do make, constitute and appoint **Megan O. Walsh**

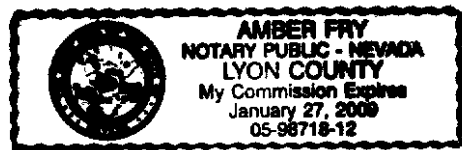
