JUDGMENT and ORDER
and CONDITIONS of SUSPENDED SENTENCE

On the 21 day of March, 20 06, Defendant appeared before the court with defendant's counsel, Wm Routsis, or without counsel. Defendant entered a plea of guilty or no contest to, or was found guilty of the following misdemeanor(s):

(Count 1) Battery DCC 9-200-481

(Count 2)

(Count 3)

(Count 4) Other charge dismissed

The defendant is hereby sentenced to a term of 180 days in Douglas County Jail, with credit for time already served and/or to pay fines, fees and assessments totaling \$ 632. ALL days of the sentence are suspended for a period of one year, and \$ 0 of the fine is suspended for a period of one year, during which time Defendant is hereby ordered to comply with the following conditions:

- Defendant shall violate no criminal laws and shall keep all Court-ordered appearances.
- Defendant shall not enter upon the premises of any Tahoe Township alcohol or gaming licensed establishments. If defendant is employed by such a premises, defendant may enter defendant's place of employment for employment purposes only.
- Defendant cannot consume or possess marijuana, alcohol or unauthorized drugs. Defendant is ordered to submit to random drug, marijuana and alcohol testing any time of the day or night with or without a warrant at the request of any peace officer and shall submit defendant's person, vehicle and residence to search and seizure at any time of the day or night, with or without warrant or probable cause, by any peace officer for the purpose of detecting the presence of drugs, marijuana or alcohol.
- Defendant shall be supervised during the period of suspension of sentence by the Department of Alternative Sentencing and pay all costs and fees associated with supervision and testing. Defendant shall follow all rules of the Department.
- Defendant shall pay fines, fees and assessments totaling 632 by 10/3/06 at 9:30 a.m. or else defendant shall appear in Court at that time.
- In lieu of paying the fines, fees and assessments, defendant may perform _____ hours of successful Community Service with Douglas County Parks & Recreation Department. Proof of payment/completion of such Community Service must be filed by _____ at 9:30 a.m. or else defendant shall appear in Court at that time.

4 Defendant shall obtain and maintain employment during the next year and report defendant's current address and home
5 and work telephone numbers to the Court, in writing, at all times.

6 Defendant shall perform 100 hours of successful Community Service with Douglas County Parks & Recreation
7 Department or with Douglas County Senior Center and file proof thereof
8 by 10-3-06 at 9:30 a.m., or else defendant shall appear in Court at such time to adequately explain
9 defendant's failure(s) to adequately perform such community service.

10 Defendant shall provide proof of insurance to the Court by _____ at 9:30 a.m., or else defendant shall
11 appear in Court at such time.

12 Defendant shall either provide proof of a valid driver's license to the Court or complete a course in automobile driver
13 education pursuant to the provisions of Nevada Revised Statutes 483.250(1)(d) or an equivalent course from defendant's
14 state of residence and thereafter provide either a valid driver's license or proof of course completion to the Court by
15 _____ at 9:30 a.m., or else defendant shall appear in Court at that time to adequately explain defendant's
16 failure.

17 Defendant may be released, subject to warrants or holds from other jurisdictions.

19 with Sandra Lane. Defendant shall appear 5-2-06 @
