This Collateral Assignment of Notes Receivable and Mortgages ("Assignment") is made and executed as of June 9, 2006, by Walley's Partners Limited Partnership, a Nevada limited partnership ("Walley's"), whose address is 213 W. - 3. Capitalized terms not otherwise defined herein shall have the meanings ascribed thereto in the Agreement.
