17 findings:

- 18 1. The Complaint in this action was filed 26 April 2006. Defendant Jerry Palmer
- 19 ("Palmer") was personally served with the Summons and Complaint on 7 May 2006.
- 20 2. Prior to filing the Complaint, Plaintiff sent Palmer two letters stating the amount he
- 21 owed, and requesting he pay his outstanding balance. These letters were sent in an attempt to
- 22 settle this dispute without the intervention of the court.
- 23 2. Palmer has failed to appear, defend, or otherwise acknowledge the pendency of this
- 24 action.
- 25 3. Palmer's Default was entered on 31 May 2006 on the Plaintiff's Application for
- 26 Entry of Default.
- 27 4. Palmer was served with a Notice of Entry of Default, via mail, on 1 June 2006.

1 5. Plaintiff brought the Motion for Entry of Judgment by Default on 6 June 2006 due
2 to Palmer's failure to appear.

3 GOOD CAUSE APPEARING THEREFORE:

4 IT IS HEREBY ORDERED that Judgment by Default shall be entered against Defendant
5 Jerry Palmer, and in favor of Plaintiff Western Power and Equipment Corporation. Said Judgment
6 shall be in the amount of \$19,067.38 as of the date appearing below, together with costs in the
7 amount of \$188.50 and attorney fees in the amount of \$1,062.00. These amounts shall accrue
8 interest at the legal rate until paid in full.
